On Booth G140, SGD Pharma will highlight its newest advancements in sustainable [glass packaging solutions](#) designed for the Beauty and Care sectors:

- Glass bottles made from 20% and 30% PCR content: A solution produced at SGD Pharma's Zhanjiang facility in China, using post-consumer recycled (PCR) glass to reduce virgin raw material use and energy consumption. In 2025, SGD Pharma has become the first glass manufacturer in China to obtain ISO 14021 certification for its PCR glass packaging, marking a significant step forward in the production of verified PCR glass for the cosmetics and beauty sector.
- NOVA lightweight glass range: Combining technical precision with sustainability, the NOVA bottle achieves up to 20% CO₂ reduction compared with standard models, demonstrating how optimized glass distribution and weight reduction can preserve both structural integrity and visual appeal.
- [ECLIPSE](#) refillable glass jar: An elegant, refillable system that encourages reuse and reduces single-use waste. Its modular design allows consumers to effortlessly replace capsules, extending the life of the outer glass container and supporting circular economy principles in beauty packaging.

Visitors will also discover SGD Pharma's advanced decoration capabilities, including cutting-edge Physical Vapor Deposition (PVD), lacquering, and screen-printing techniques that enable brand differentiation while remaining compatible with recycling processes. These technologies deliver high-end finishes that combine luxury aesthetics with eco-responsible design.

Decarbonization: leading with purpose

SGD Pharma reaffirms its strong commitment to sustainability through the 3R principles – Reduce, Reuse, Recycle – which guide its product development and manufacturing philosophy. This approach drives every innovation toward minimizing environmental impact while upholding the highest standards of quality, safety, and aesthetics.

SGD Pharma has again been awarded the EcoVadis Platinum medal with a score of 90, positioning the company as the global leader of cosmetic and pharmaceutical glass manufacturers worldwide for sustainable performance. This recognition celebrates SGD Pharma's unwavering commitment to environmental, social and ethical excellence across all its global sites, reaffirmed through robust governance, decarbonization initiatives, and sustainable procurement practices.

Building on its Science Based Targets initiative (SBTi)-validated roadmap, SGD Pharma is on track to achieve a 42% reduction in carbon emissions by 2030 and 65% by 2040, compared to 2022 levels. The company's holistic sustainability strategy extends from energy efficiency investments to responsible sourcing and workforce inclusion.
